RESOLUTION 26/27-02

A RESOLUTION CORRECTING THE FISCAL YEAR 2026-27 BUDGET RESOLUTION BY REMOVING THE LANGUAGE RELATED TO THE LOCAL OPTION LEVY

BE IT RESOLVED that on June 17, 2026 the Board approved Resolution No. 26/27-01 adopting the budget and making appropriations for Fiscal Year 2026-2027, which contained a drafting error omission by including the local option levy that did not pass and for which the district will not levy a rate.

Further, BE IT RESOLVED that it is necessary to pass a resolution to properly document the accurate tax levies to align with the LB-50 form submitted to the County Assessor's office reflecting the levies as approved by voters and under budget law, and that the corrected resolution is below.
